



INFORMATION FOR APA ASSOCIATE MEMBERSHIP

Associate Membership of the APA is for a period of 12 months (from acceptance and payment of fees) after meeting the membership requirements for an astrological education and training qualification. Associate Members must be working towards meeting the full requirements of APA membership.

Information and guidelines for APA Associate Membership include the following criteria:

2. Counselling requirements

1. Astrological Education, Training and Qualifications

Please attach as evidence a certified** copy of your

- FAA Practitioners Diploma
- Astro*Synthesis Diploma
- Astro Logos Diploma

OR

- other qualifications accepted by the Association of Professional Astrologers International (UK)

OR

for other qualifications to be considered you need to provide evidence that the qualification included the completion of the Association's required 320 hours of theoretical and practical training over a minimum of four years.

** a certified copy is a copy that a Justice of the Peace signs off as a true copy of the original document.

2. General Counselling Theory Education

Professional members of the APA are required to have completed of a minimum 30 hours counselling theory and provide certified evidence of this education. As an Associate Member, you will be working towards attaining this education. A written plan is required to set out how this criterion will be met whilst an Associate Member to meet the Professional Membership requirements. The plan must be accepted by the Standards (Membership) Committee prior to the approval of Associate Membership.

It is preferable that the counselling theory education is completed before entering into a supervision agreement as this is more likely to be beneficial to the Associate Member.

To meet this requirement please attach your PLAN to gain counselling theory education for the required 30 hours

OR

If you have completed this requirement please attach certified evidence of completion.

Once the 30 hours counselling theory is completed certified evidence should be sent to the Membership Convenor.

3. Supervision

In addition to the required education and training hours, both astrological and counselling, Professional Members must have participated in supervision for a minimum of 25 hours with an APA approved Supervisor. Other associations that provide supervision with accredited Supervisors in local areas include PACFA (Psychotherapy & Counselling Federation of Australia) www.pacfa.org.au or ACA (Australian Counselling Association) www.theaca.net.au

For supervision to meet Professional Membership criteria there must be an arrangement specifically for the purpose of supervision between the supervisor and supervisee prior to supervision taking place. A written supervision plan, including the details of the supervisor must be submitted prior to commencement of the supervision plan. An APA Supervision Log is available upon request. The supervision log is to be completed in conjunction with your proposed supervisor and signed off by both supervisee and supervisor at each supervision session.

A supervision plan is to be submitted with your Associate Membership application. The supervision plan must be accepted by the Standards Committee prior to the approval of Associate Membership.

On the completion of the approved supervision plan the Associate Member is required to provide a reference from the agreed supervisor to the Membership Convenor as to successful completion of the supervision plan and a certified copy of supervision log. The reference will be provided to the Standards Committee. This reference is in addition to the two referees needed for Associate Membership approval.

More than one supervisor may provide supervision but applicants need to register the name of their principal supervisor and this person will oversee the applicants' astrological supervision log. The supervision log of all supervision hours must be kept and signed by the supervisor (s) and supervisee at the time of each supervision session.

The hours accredited as "supervision" must be different from those hours accredited as "training".

In the case of group supervision, a proportion of the total number of hours of supervision should be accredited to each individual supervisee. Group supervision shall be accredited as follows:

- 1 – 4 (inclusive) supervisees: the total number of hours is accredited
- 5 – 6 (inclusive) supervisees: 2 hours for every 3 hours shall be accredited
- 7 – 8 (inclusive) supervisees: 2 hours for every 4 hours shall be accredited
- 9 supervisees or more is considered training, not supervision.

4. Extension of Associate Membership

An application, in writing must be made to the Membership Convenor for an extension of Associate Membership for a specific period if, after 12 months of Associate Membership, the counselling and supervision requirements for membership are not completed. The application should set out the reasons for the request and progress towards meeting the requirements for Professional Membership.

The application must be received before the expiration of Associate Membership occurs. The Membership Convenor will forward the application to the Standards Committee for assessment and an extension may be accepted or rejected. The extension period if granted will consider the applicants requested timeframe but may set a shorter period.

5. Nominator and Referee's

Applicants must be nominated by a Professional Member of the APA and a written reference provided by the nominator. A second written reference from another Professional Member of the Association also needs to be provided with your application.

6. Individual Assessment

The Standards Committee appointed to assess all membership applications will assess each membership application on its merits and the Committee may accept or reject any application.

7. Associate Membership Fees and General Information

Associate Member fees are set at a reduction to Professional Membership fees and those fees and a joining fee is required to be paid on acceptance as an Associate Member.

On approval of your Associate Membership application, an Executive Member of the APA will contact you with details of how to pay your joining and member fees to complete your acceptance as an Associate Member. Fees are not payable before acceptance.

If your Associate Membership lapses and no extension has been applied for then another application for Associate Membership will be required if you chose to reapply.

Associate Members do not have voting rights at Annual General Meetings or the privileges of full members i.e. subsidies for professional development or entitlement to access Professional Indemnity Insurance.

Associate Members will receive the quarterly APA Newsletter, be kept informed on APA events, professional development and networking opportunities and advice as needed by the Membership Convenor.

9. Membership Convenor's Role

The role of Membership Convenor is to: -

- Provide interested parties with information on how to complete membership application forms and the provision of required documentation
- Oversee the progress of membership applications
- Notify applicants of the receipt of applications and of any additional information that is required.
- Liaise between the Standards Committee and membership applicants
- To oversee supervisory arrangements for Associate Members including the registration and acceptance by the Standards Committee of the proposed supervision plan and completion of astrological supervision logs.
- To confirm with the Standards Committee the completion by Associate Members of counselling and supervision plans after being provided with the required documentation.
- Provide a copy of all certified documents related to applications i.e. qualifications, counselling theory and supervision documents plus written references provided to nominate and support applications to the Standards Committee

10. Before submitting your Associate Membership Application ensure that:

- You and your nominator has signed the application as required

- All details are correct and your documentation is certified (copies signed by a Justice of the Peace as true copies of the originals)
- Preference is for all applications and documents to be provided electronically as a PDF to the Membership Convenor at membershipenquiries@apainc.org.au
- If you plan to post your application and documents contact the Membership Convenor at membershipenquiries@apainc.org.au for the postal address for your application. It is highly recommended you use Express Post so you can track the delivery of your application.

11. Professional and Associate Membership Requirements (APA Inc Constitution)

1. Membership generally

- (1) A person is eligible to be a member of the association if:
 - (a) the person is a natural person, and
 - (b) the person has been nominated and approved for membership of the association in accordance with clause 4.

- (2) A person is taken to be a member of the association if:
 - (a) the person is a natural person, and
 - (b) the person was:
 - (i) in the case of an unincorporated body that is registered as the association - a member of that unincorporated body immediately before the registration of the association, or
 - (ii) in the case of an association that is amalgamated to form the relevant association - a member of that other association immediately before the amalgamation, or
 - (iii) in the case of a registrable corporation that is registered as an association - a member of the registrable corporation immediately before that entity was registered as an association.

- (3) A person is taken to be a member of the association if the person was one of the individuals on whose behalf an application for registration of the association under section 6 (1) (a) of the Act was made.

2. Nomination for Membership

- (1) A nomination of a person for membership or associate membership of the Association -

- a. shall be made in writing in the prescribed form, signed by a member of the Association;
- b. shall be accompanied by the written consent of the person nominated (which may be endorsed on the form of nomination); and
- c. must be lodged with the secretary of the Association.

(2) A person who is not a member of the Association at the time of the incorporation of the Association shall not be admitted to membership unless-

- a. s/he is nominated as provided in sub-rule (d) of this rule; and
- b. his/her admission as a member is approved by the committee; and
- c. s/he has passed an examination in astrology recognised by the association as requiring the applicant to be of a professional standard in the practice of astrology. The Standards Committee of the association once formed will advise the Committee which examinations may be accepted under this sub rule;
- d. s/he meets the requirements regarding counselling training and supervision hours as agreed by the standards committee
- e. s/he provides two supporting references from professional members of this association
- f. s/he is required to meet any other requirements that maybe set by the standards committee from time to time to provide evidence of proficiency in applied practical astrological counselling.
- g. s/he has agreed to abide by the APA Statement of Professional Behaviour (Schedule 1)

(3) A person who is not a member of the Association at the time of the incorporation of the Association shall not be admitted to associate membership for 12 months unless

- a. s/he meets requirements of Sub-rules 2.a) b) and c)
- b. s/he is prepared to arrange, complete and provide evidence of completion of the counselling and supervision requirements for membership as set by the standards committee and to meet any related costs that may be incurred.
- c. s/he is required to provide for approval to the standards committee a written supervision plan, including details of the supervisor prior to commencement of the supervision plan.
- d. s/he is required to be prepared, on completion of the supervision requirements to request and provide to the standards committee a reference from the agreed supervisor as to successful completion of the supervision plan before membership is granted

- e. s/he is required to apply in writing to the standards committee for an extension of associate membership for a specific period if after 12 months of associate membership the counselling and supervision requirements for membership are not completed.
- f. s/he is required to meet any other requirements that maybe set by the standards committee from time to time to provide evidence of proficiency in applied practical astrological counselling.
- h. s/he has agreed to abide by the APA Statement of Professional Behaviour (Schedule 1)
- g. an associate member will not have voting rights.
